

PRESENTATION OF "NBT®BNBREPO"

"NBT®BNBREPO" IS A COMPLEX SOFTWARE SOLUTION OFFERED BY NBT TO THE BANKS IN BULGARIA WHICH HELPS THEM TO FORM THE REGULATORY REPORTING REQUIRED BY BNB. THE SOLUTION IS INTENDED FOR BANKS WHO WANT TO PREPARE REPORTS ON THE BNB FASTER, EASIER AND MORE PRECISE.

THE MAIN BENEFIT OF USING THIS SOFTWARE SOLUTION IS THAT THE BANK RECEIVES QUALITY AND TIMELY CONSULTING IN A RAPIDLY CHANGING REGULATORY BASIS AND THE GUARANTEED LACK OF CONTRADICTIONS BETWEEN THE DATA FROM THE DIFFERENT REPORTS FOR BNB.

THE SOLUTION INCLUDES AN AUTOMATED INFORMATION SYSTEM WITH THE SAME NAME, CONSULTATIONS ON ITS IMPLEMENTATION AND PRODUCT SUPPORT AT CREATING THE REPORTS.



IF NECESSARY TO THE MODULAR STRUCTURE OF THE SYSTEM COULD BE ADDED MODULES FOR FEEDBACK ON INITIAL DATA TO ACCOUNTING SYSTEM OF THE BANK FOR AUTOMATED REFLECTING OF SPECIFIC ESTIMATES.

THE TECHNOLOGICAL REALIZATION OF THE SYSTEM IS CLIENT-SERVER-APPLICATION WHICH ALLOWS THE REPORTS TO BE MADE IN A NETWORK AND AS FAR AS POSSIBLE INDEPENDENTLY FROM EACH OTHER, NOT ONLY FOR ONE BUT FOR SEVERAL DATES TOO.

USUALLY THE MODULE STRUCTURE OF "NBT®BNBREPO" IS (FIG.1):

- NONSTANDARD PART IT INCLUDES THE PROCESSES WHICH DRAW THE DATA NEEDED FOR BNB
 REPORTS FROM THE ENTIRE INFORMATION STREAM OF THE BANK

 BETWEEN DIFFERENT REPORTS. ALL THE NECESSARY PAPERS AND FILES FOR BNB AND THE BANK
 ITSELF ARE FORMED HERE TOO.
